RE: Black Lives Matter Movement (Internal Use Only)

Presidential candidates have struggled to respond to tactics of the Black Lives Matter movement.

While there has been little engagement with House candidates, candidates and campaign staff should be prepared. This document should not be emailed or handed to anyone outside of the building. Please only give campaign staff these best practices in meetings or over the phone.

Please see below for best practices:

#### Background

#### What does BLM want?

- · Radical movement to end "anti-black racism"
  - Though police abuses are a central component, the founders view the movement more broadly
- Criminal Justice System reform: sentencing reform, ending prison industrial complex, police reform: referring to hiring, training, and unfair policing tactics.
- An end to police brutality, the killings of unarmed African Americans (the impetus
  of the movement being the acquittal of George Zimmerman)
  - · Collect data on police shootings
  - · Demilitarization of the police

#### Tactics

#### Meet with Local Activists

If approached by BLM activists, campaign staff should offer to meet with local activists. Invited BLM attendees should be limited. Please aim for personal or small group meetings.

- · Listen to their concerns
- · Don't offer support for concrete policy positions
- · Frontline district staff should meet with activists

#### Introduction

This memorandum briefly addresses how Members of the House of Representatives and official House staff may voluntarily support congressional campaigns. The guidance in this memo will help to ensure that any volunteer participation is in compliance with legal and ethical requirements.

#### Guidance

#### A. Official Staff Participation in Campaigns

#### 1. Restrictions and Conditions on Official Staff Campaign Activity

Official staff may participate in campaign activities during a federal election, but there are a number of restrictions on how official House staff may engage in campaign activity in compliance with legal and ethical requirements. Such activity must be voluntary and should in no way interfere with the performance of a staffer's official duties.

A House staffer may only volunteer for a campaign on his or her own time. This time may be available in off-hours, or during periods of bona fide vacation or leave time. It is not necessary for a House staffer to cease his or her official employment to volunteer with a political campaign as long as the volunteer work is not done on official time and does not take away from official duties.

No official House resources (including staff time, computers, fax machines, telephones, and copiers) may be used to benefit a campaign; they are to be used solely for legislative and representative purposes. Campaign activity is also prohibited in House offices, and House telephone numbers may not be used for campaign purposes.

### Recent Immigration Reform Proposals from the 113th Congress

#### Terms to Know

Pathway to Citizenship: Provides a way for undocumented immigrants to attain citizenship. Most proposals require background checks, payment of back taxes, and fluency in English as criteria for eligibility. Most proposals also contain intermediary steps such as new legal status or permanent legal status before the citizenship process begins. Additionally, supporters of a pathway to citizenship want to ensure "no uncertainty" for eligible immigrants on whether or not they will attain citizenship.

**Employer Verification:** Requires employers to verify the legal status of their employees. Most proposals include mandatory use of the E-Verify system for medium to large business within two to three years of the bill's passage. Currently, 20 states mandate that some business use the E-Verify system, which has become more accurate recently. 96% of all immigration checks made through the system were found to be accurate.

**Border Security:** Recent proposals have made a pathway to citizenship contingent on enhanced border security. Plans to improve border security include investments in border infrastructure and an increase in border security agents. However, studies have shown that raising the level of security along the border couldn't happen until 2019 and would cost twice the amount spent in 2012, roughly \$28 billion a year. Reports have also shown that the level of illegal border crossings decreases substantially when the Mexican economy performs better, as it has been recently. This raises questions about the cost effectiveness of additional border security spending.

STEM Education and High Skilled Immigrants: STEM stands for science, technology, engineering, and mathematics. Currently, H1-B visas are issued for skilled workers. They are capped at 65,000 for all workers and 20,000 for workers with a master's degree or higher. Nonprofit organizations, governmental research institutions, and universities are exempt from this cap. Demand for these visas far outpaces the current cap of 85,000. H1-B Visas can only be issued for established business. Opening them to potential entrepreneurs is a policy gaining significant attention because of its job creation potential.

"DREAMers": Unauthorized immigrants who are under the age of 31; entered the United States before age 16; have lived continuously in the country for at least five years; have not been convicted of a felony, a "significant" misdemeanor, or three other misdemeanors; and are currently in school, graduated from high school, earned a GED, or served in the military.

Re: ISIS Backgrounder

#### Origins

In short: Our invasion created the atmosphere for a Jordanian to start a Muslim sectarian war, which ultimately created ISIS.

Zarqawi enters Iraq: When the U.S. invaded Iraq in 2003 we triggered a massive insurgency against our presence. Around this time, a Jordanian ex-convict named Zarqawi travelled to Iraq with one goal: to establish a religious state just for Sunni Muslims. Zarqawi wanted a civil war between Sunnis and Shias and led attacks on Shias that triggered counterattacks. Zarqawi's attacks on Muslims in the name of Islam drew condemnation from other jihadist groups and figures (including Bin Laden).

**Iraqi Mistakes:** The Administration of Iraq's Prime Minister (Maliki) was discriminatory to Sunnis, which helped recruit Sunni Iraqis to Zarqawi's group. Maliki's prejudicial governing style worsened after U.S. troops left Iraq, helping quickly deteriorate the situation further.

**Now called ISIS:** Zarqawi was killed by American forces in 2006. His successors now lead the Islamic State in Iraq and Syria (ISIS).

## Benghazi Aftermath

Value statement: Let's remember the sacrifice of these Americans, not reduce their names to political talking points. We must protect and value our diplomats.

On September 11, 2012, an attack in Benghazi, Libya resulted in the deaths of two CIA contractors and two American diplomats, including U.S. Ambassador Chris Stevens. The country was already in chaos after the NATO-aided toppling of brutal long-term dictator Muammar Qaddafi the month before.

Glen Doherty and Tyrone S. Woods: CIA contractors killed in the attack

Susan Rice: Former U.S. Ambassador to the U.N., who gave incorrect information

Ahmed Abu Khattala: Militia member arrested by U.S. for alleged participation in Benghazi attack, awaiting trial in DC

Muammar al-Qaddafi (aka Qaddafi or Gaddafi): Libyan Dictator toppled by Libyans and NATO in August 2011

American diplomats in Libya,

Officials and the media struggled in the aftermath to assemble a coherent narrative of the confusing, tragic events. On September 16, then-Ambassador to the United Nations Susan Rice gave incorrect information on television, suggesting the attacks arose spontaneously from a protest of an anti-Islam video produced in the United States, which contradicted some early reports and which later proved false. The violence is now believed to have been a planned attack by extremists with ties to Islamist anti-Qaddafi militias, which were gaining power in the post-Qaddafi vacuum.

An alleged leader of the attack, Ahmed Abu Khattala, was arrested in Libya in June 2014 and brought to Washington, DC to await trial. He had a routine detention hearing in early July 2015.

The political and media climate was, and remains, both emotional and pedantic. **Legitimate outrage over the deaths of American diplomats mixed with partisanship.** Then-Amb. Rice was accused of deliberately lying about the circumstances of the attack for political reasons, and Pres. Obama was grilled for his initial choice of termiology: "act of terror" instead of "terrorist attack." The word "Benghazi" itself has become a wry shorthand among the political left for hysterical conservative conspiracy theory.

Recurring questions and sticking points include:

- the motivation for and level of premeditation of the attack,
- if U.S. intelligence agencies had prior knowledge of a specific credible threat against
