

## Recent History of American Gun Control.

- In 1988, Senator (((Howard Metzenbaum))) sponsored bill S-1523, which proposed turning every violation of the Gun Control Act of 1968 into a RICO offense, which would have allowed a gun owner to be presumed “a racketeer” (just like Mafia crime bosses) just for owning a gun with a high-capacity magazine or a front sight painted the wrong color.
- Later in 1988, (((Metzenbaum))) co-sponsored bill S-2180, which would ban guns made mostly from hard plastic.
- In 1990, Senator (((Herbert Kohl))) proposed bill S-2070, which became the Gun-Free School Zones Act of 1990, which, by banning gun possession in school zones. (Note: the law was later struck down by the Supreme Court as unconstitutional)
- In 1993, Sen. (((Howard Metzenbaum))) sponsored bill S-653, which banned specific semiautomatic rifles, mostly on the basis of how “dangerous” it looked to a liberal ignoramus. **It also gave the Secretary of the Treasury the power to add any other semi-auto firearm to the banned list going forward.**
- In 1994, the Brady Bill became effective. Sen. (((Metzenbaum))) wrote the Brady Bill and sponsored it in the Senate, while (((Charles Schumer))) sponsored it in the House.
- In 1994, Sen. (((Metzenbaum))) introduced S-1878, the Gun Violence Prevention Act. The same bill, named HR-1321, was sponsored in the House by (((Charles Schumer))).
- In 1994, the Violent Crime Control and Law Enforcement Act of 1994 went into effect, which, among other things, banned the manufacture and possession of semi-auto rifles described as “assault weapons” (**Note: a lie used to redefine the auto military weapons to include semi-auto sporting rifles going forward**). It was proposed in the Senate by (((Diane Feinstein))) and in the House by (((Charles Schumer))).
- In 1995, Senators (((Feinstein))), (((Kohl))), (((Lautenberg))), and (((Specter))) introduced the Gun-Free School Zones Act of 1995, in order to get around the Supreme Court’s earlier striking-down of a similar Act passed in 1990.
- In 1996, the Lautenberg Domestic Confiscation provision became law. **It was quietly slipped into law as a rider on a larger appropriations bill, and bans people convicted of misdemeanor domestic violence from ever owning a gun.** It was sponsored by (((Senator Frank Lautenberg))).
- In 1997, Senate bill S-54, the Federal Gang Violence Act of 1997, which makes the slightest infraction of the Gun Control Act of 1968 a RICO offense and proposes much harsher sentences for people violating minor gun laws, including mandatory prison sentences and forfeiture of property. It was introduced by (((Diane Feinstein))) and by Senator Orrin Hatch (an honorary Jew).
- In 1999, Senator (((Barbara Boxer))) introduced bill S-193, the American Handgun Standards Act of 1999. At the same time, Senator (((Herbert Kohl))) introduced bill S-149, the Child Safety Lock Act of 1999. **Can’t be prepared to defend yourself in your own home, Citizen.**
- In 1999, all in about six weeks, Sen. (((Frank Lautenberg))) introduced bill S-407, (the Stop Gun Trafficking Act of 1999), and S-443 (the Gun Show Accountability Act of 1999), and S-560 (Gun Industry Accountability Act of 1999).
- In 1999, Senator (((Diane Feinstein))) introduced bill S-594, the Large Capacity Ammunition Magazine Import Ban Act of 1999.
- In 2000, Senators (((Feinstein))), (((Boxer))), (((Lautenberg))), and (((Schumer))) sponsored Senate bill S-2515, the Firearm Licensing and Record of Sale Act of 2000, which was a plan for a national licensing system for guns.

- In 2001, Senators (((Feinstein))), (((Schumer))), and (((Boxer))) sponsored Senate bill S-25, the Firearm Licensing and Record of Sale Act of 2001. This is apparently a different version of the bill proposed by Jewish legislators in 2000.
- In 2003, Senators (((Feinstein))), (((Schumer))), and (((Boxer))) would introduce legislation that would reauthorize the 1994 federal “assault weapons” ban (**which implicitly assumed that certain non-assault weapons would be legally treated as assault weapons**), and closed a so-called loophole in the law that allowed high-capacity magazines to be imported to the US.
- In 2003, Senators (((Feinstein))), (((Lautenberg))), (((Levin))), and (((Schumer))) sponsored bill S-1774, intended to continue the Undetectable Firearms Act of 1988.
- In 2005, (((Frank Lautenberg))) and (((Diane Feinstein))) each introduced bills having a long double-think propaganda names, the purpose of which was to reinstate the 1994 assault-rifle ban (which included certain rifles that are not assault rifles because they cannot fire in full-auto mode).
- In 2005, (((Diane Feinstein))) introduced bill SA 1621, which restricted weapons that fire .50 caliber bullets and referred to them as “sniper weapons.” She also introduced bill SA-1622, which allowed lawsuits against persons using .50 caliber weapons.
- In 2005, Senator (((Barbara Boxer))) introduced bill SA-1633, which enables lawsuits when a rifle doesn’t meet the safety standards as defined by (one version or another of) the BATFE. She also introduced SA-1634, which would attempt to ban most handguns in the United States through the use of a “sporting use” legal requirement. **(Note: in the legal system, self defense is not a valid reason to own a handgun - unless you're employed defending a Politician)**
